

Topic: Strengthening Cooperation, Trade, & Investment Between African and Caribbean States

As Barbados' first diplomatic representative to Kenya, H.E. William A. McDonald boasts a rich background as businessman, entrepreneur, and public servant. He represents the interests of Barbados at the United Nations office in Nairobi, the African Union and the 12 other countries for which his remit stands. The Barbados High Commission to Kenya is the primary diplomatic mission of Barbados to Kenya and Rwanda, with jurisdictional oversight of Botswana, Ethiopia, Lesotho, Malawi, Mauritius, Seychelles, South Africa, Tanzania, Uganda, and Zambia.

As Principal Secretary for Diaspora Affairs, I am charged with promoting continuous dialogue with Kenyans abroad, championing the protection of Kenya's diaspora rights and welfare, developing an incentive framework for diaspora remittances, harnessing diaspora savings, facilitating foreign direct investment (FDI) and technology transfers, and mainstreaming the Kenyan diaspora into the national development process.

ARC's main objective is to study and inform bilateral agreements between Africa and the Caribbean using a decolonial framework. Moreover, Dr. Eugene's research takes up the historical struggles for reparations by conceptualizing it as a liberation praxis for enslavement, colonialism, and neocolonialism in new worldmaking.
